



- Class 8 liquids 23≤FP≤60 °C having subsidiary risk class 6.1 are prohibited (5)
- (6) Class 8 liquids having subsidiary risk class 6.1 are prohibited
- Under the provision of IMDG Code, stowage of class 2.3 having subsidiary risk class 2.1 under deck or in enclosed ro-ro space is prohibited (7)
