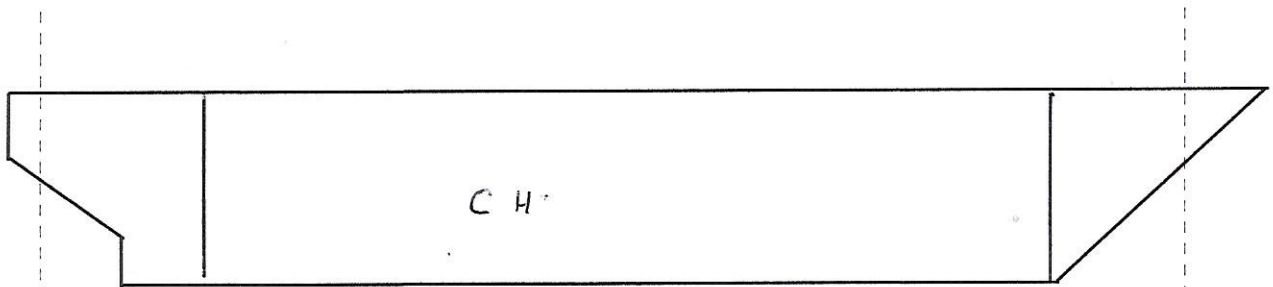

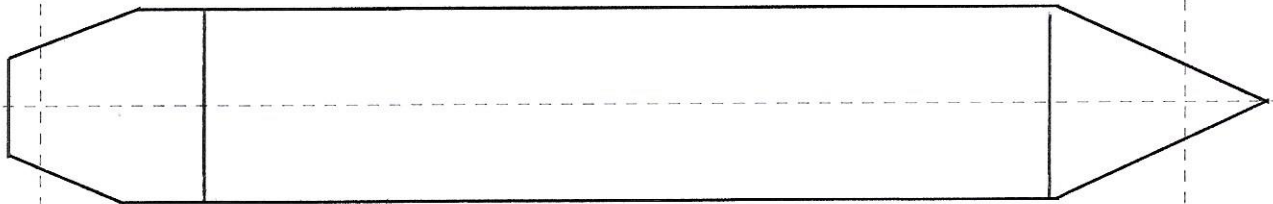

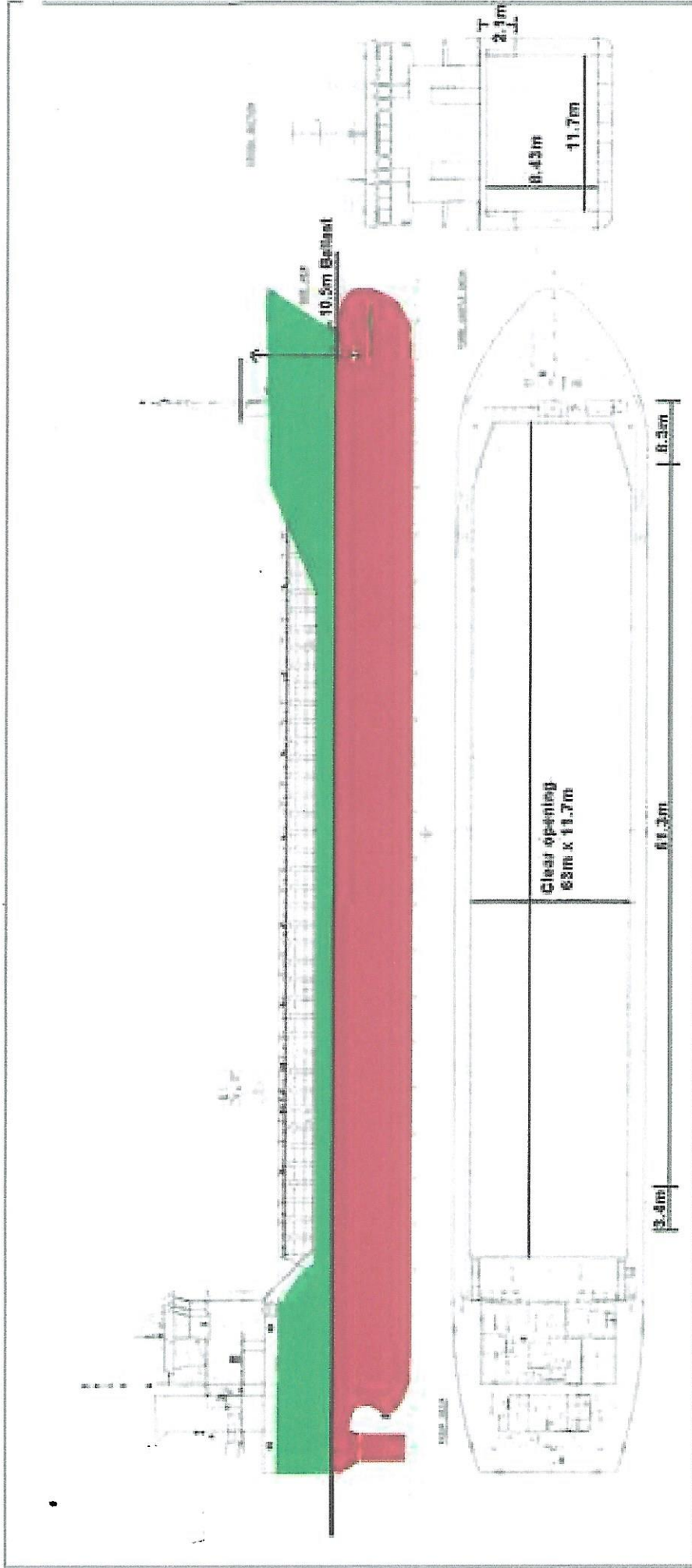

Attention is also to be paid to stowage and segregation provisions of the IMDG Code

- (1) To be stowed 3 m horizontally away from the machinery space boundaries
- (2) Electrical equipment which is not essential for the safety and operation of the ship and which is not of a type approved for use in the considered area shall be:
 - completely disconnected by appropriate means other than fuses at a point external to the space
 - protected against unauthorized re-connection
- (3) Under the provision of IMDG Code, stowage of class 2.3 having subsidiary risk class 2.1 under deck or in enclosed ro-ro space is prohibited
- (4) **[specific for Bulk transport only]** Electrical equipment which is not essential for the safety and operation of the ship and which is not of a type approved for use in the considered area shall be:
 - completely disconnected by appropriate means other than fuses at a point external to the space
 - protected against unauthorized re-connection
- (5) Under the provision of IMDG Code, stowage of class 4.3 liquids having a flashpoint less than 23°C under deck or in enclosed ro-ro space is prohibited
- (6) Class 8 liquids $23 \leq FP \leq 60$ °C having subsidiary risk class 6.1 are prohibited
- (7) Class 8 liquids having subsidiary risk class 6.1 are prohibited
